
It is hereby notified to all newly admitted students seeking admission into B.A. 1st Semester at Halakura College that those who wish to avail admission under the Government Fee Waiver Scheme must submit a valid **Family Ration Card**.

The ration card may be in the name of the student or in the name of his/her father, mother, grandfather, or grandmother. Additionally, the ration card must clearly indicate **BPL (Below Poverty Line)** status.

It is further informed that **income certificates issued by any authority will not be accepted** in place of the ration card.

Students who fail to submit a valid ration card will be treated under the **APL (Above Poverty Line)** category. Such students will be required to pay the full annual course fee of Rs. 7,180/- at the time of admission, based on the 1st and 2nd Merit Lists, and subsequently during spot admission.
